Governance & Bylaws

Discussion was held in regard to a proposed of revision to bylaws as follows:

- 5.04 Term of Office
- (a) Each elected officer other than the executive director shall serve for a term of one year or until his successor shall have been elected and qualified, unless otherwise herein specified. Officers may be re-elected to successive terms, except the holder of the office of president may not succeed himself more than once, unless, in extraordinary circumstances, the Nominating Committee deems it in the best interest to nominate the current president for possible election to a third one-year term. The term of each office shall begin on January 1 of the year following the meeting at which such officer was elected.

Motion made to revise the bylaw 5.04 but failed to carry.
